READ CAREFULLY WAIVER AND RELEASE OF LIABILITY

In consideration of **Magic Falls Rafting Company**, (herein after **Magic Falls**), furnishing services and/or equipment to enable me to participate in **whitewater rafting, rock climbing, kayaking, inflatable kayaking, hiking, overnight camping trips, etc.** I agree as follows:

I fully understand and acknowledge that outdoor recreational activities have: (a) Inherent risks, dangers and hazards and such exists in my use of **Magic Falls** recreational equipment and my participation in **whitewater rafting, rock climbing, kayaking, inflatable kayaking, hiking, overnight camping trips, etc.**, activities; (b) my participation in such activities and/or use of such equipment may result in injury or illness including, but not limited to bodily injury disease, strains, fractures, partial and/or total paralysis, death or other ailments that could cause serious disability; (c) then risk and dangers may be caused by the negligence of the owners, employees, officers or agents of **Magic Falls**: the negligence of the participants, the negligence of others, accidents, breaches of contract, the forces of nature or other cause. Risks and dangers may arise from foreseeable or unforeseeable causes including, but not limited to, guide decision making, including that a guide may misjudge terrain, weather, trail or river mute location, and water level risks of falling out of or drowning while in a raft canoe or kayak and such other risks, hazards and dangers that are integral to recreational activities that take piece in a wilderness, outdoor or recreational environment; and (d) by my participation in these activities and/or use of equipment, I hereby assume all risks and dangers and all responsibility for any losses and/or damages, whether caused in whole or in pan my the negligence or other conduct of the owners, agents, officers. or employees of **Magic Falls** or by any other person.

I, on behalf of myself, my personal representatives and my heirs hereby Voluntarily agree to release, waive, discharge, hold harmless, defend and indemnity **Magic Falls** and its owners, agents, officers, and employees from any and all claims, actions or losses for bodily injury, property damage, wrongful death, lon of services or otherwise which may arm out of my use of **Magic Falls** recreational equipment or my participation in **whitewater rafting, rock climbing, kayaking, inflatable kayaking, hiking, overnight camping trips, etc.** activities.
